### HOW TO PRE-REGISTER

1. FILL OUT THE PREREGISTRATION FORM: Print clearly.
2. FILL OUT THE REQUIRED WAIVER(S):

#### **ADULTS (18 YEARS OF AGE AND OLDER)**

- **SCA BLUE CARD MEMBERS**<sup>1</sup> must present their card at gate and have their card with them at all times.
- **SCA WHITE CARD MEMBERS** and **NON-MEMBERS** must complete the **SCA Adult Event Waiver**.

#### **MINORS (17 YEARS OF AGE AND YOUNGER) Accompanied by parent / legal guardian**

- **SCA BLUE CARD MEMBERS**<sup>1</sup> must present their card at gate and have their card with them at all times.
- **SCA WHITE CARD MEMBERS** and **NON-MEMBERS** must complete the **SCA Minor Event Waiver**<sup>2</sup> or if multiple related children the **SCA Multiple Minors Event Waiver**<sup>2</sup>.

#### **MINORS (17 YEARS OF AGE AND YOUNGER) Accompanied by an adult who is not their parent / legal guardian**

- **SCA BLUE CARD MEMBERS**<sup>1</sup>, **SCA WHITE CARD MEMBERS** and **NON-MEMBERS** must complete the **SCA Minor Event Waiver**<sup>2</sup> or if multiple related children the **SCA Multiple Minors Event Waiver**<sup>2</sup> and the **SCA Medical Authorization for Minors** which must accompany the minor and the responsible adult at all times.

<sup>1</sup> *If the member is unable to present a valid proof of membership they must sign the waiver form.*

<sup>2</sup> *Minor waivers must be signed by Parent or Legal guardian. A copy of the Parent/ Legal guardian's state ID must accompany the waiver. The Parent / Legal guardian's signature and name must be clearly visible on the copy.*
